Our Purpose

Our purpose is to teach children about the wonderful blessing of being God's children through faith in Jesus Christ. This will be accomplished by using God's law to show children their need for a Savior, and God's gospel to show children that Jesus is their Savior.

Parents play a vital role in accomplishing this purpose. Therefore, we will also offer parents encouragement, opportunities, and help in fulfilling their roles as parents.

Our entire Messiah Church family cares about those who attend our preschool. Our goal is that the pastor, director, teaching staff, parents, students and congregation work together for a single goal of Christ-centered excellence in early childhood education. Our pastor is involved in leading Preschool Church, interacts with parents and students regularly, and is ready and willing to offer spiritual guidance and counsel to any of our school families. It is strongly encouraged that parents take advantage of any instruction classes that are provided, so that you are familiar with the instruction in God's Word your child will receive. Those opportunities will be announced regularly.

Is Your Child Ready For Preschool?

- THEY MUST BE ABLE TO:
- work and play with other students of the same age.
- use the bathroom by themselves and are daytime toilet trained.
 - handle their own clothing and wash their own hands.
- sit for short periods of time and attend to a task.
- participate in discussions: one-on-one, small groups, and a large group.
- listen to and follow simple directions.

Registration Requirements

- Registration requirements are as follows:
- the child is three or four years old before September 1st of the enrollment year for appropriate class
- you verify your child is ready for preschool as described previously
- the completion of all forms
- copies of immunization record and birth certificate accompany the application
- non-refundable application fee paid

Daily Schedule

- All classes will follow the Daily Class Schedule for 3's and 4's from 9:00-12:00.
- Any children enrolled in the **all-day** program will follow the afternoon schedule. The afternoon will include lunchtime. Please note that parents must provide sack lunches for their children. We will keep them refrigerated and distribute them at lunch break.
- The afternoon schedule will not be curriculum based but will be more relaxed and provide time for learning games, art and cooperative learning activities. These types of activities are often cut short in the morning due to our schedule.

School Year and Closings

- Our school year runs from Labor Day through the end of May with school vacations running in accordance with the *Nampa School District*. **The preschool will remain open on Nampa School “In Service” days.** A school year calendar will be provided.
- We observe the following holidays, therefore there will be No school on:

- In cases of bad weather, we will follow Nampa School District for closing. This closure will not be made up if only one class period is canceled. In the event of additional closures, a make-up class will be considered on an “as needed” basis.
- In the event of an emergency closing, parents will be contacted via the “Wonderschool” App.

Attendance and Illness

- Notify the teacher when your child will be absent. Please use the preschool phone number 208-465-4511 or contact your child's teacher via "Wonderschool". Please leave a message if there is no answer.
- **PLEASE, DO NOT BRING A SICK CHILD TO SCHOOL!** If there is any doubt, it is best to keep your child home. If you have questions regarding an illness, please call the school **prior** to bringing your child to class.
- If your child has had a fever, diarrhea, or vomited within 24 hours prior to the session, **DO NOT BRING YOUR CHILD TO SCHOOL.** You will be called to pick up your child if he/she becomes sick at school.
- All contagious illnesses (covid, chicken pox, etc.) or situations (head lice, etc.) *-or exposure to-* should be reported to the teacher so other parents can be informed. In such cases, a child's identity will be held in strict confidence.
- Parents should report to the teacher or the Preschool if an extended absence occurs. This allows the school to know the intent of the parents to keep the child enrolled as a student.

Immunization Policy

- Idaho State Law (Idaho Code 39-1118) requires licensed childcare providers to keep immunization records on file for all children ages 4 months to 12 years, including provider's own children.
- Immunization records must include name of child, date of birth, and the day, month, and year of each immunization the child received.
- Immunization records must be provided before child starts attendance at Messiah's Children Preschool.
- Children with immunizations missing, incomplete, or not up to date will be excluded from Messiah's Children Preschool until documentation of current immunizations is provided.
- Parents are responsible for providing current documentation each time the child completes a series.
- Immunizations help protect all children and staff from several diseases.
 - Below is our response to the three main objections to vaccinations based on our religious beliefs.
 - Information found on <https://wels.net/faq/immunizations>
 - Objection #1: Vaccinations represent a failure to trust the providence of God as the Great Physician and Protector.
 - Yes, we are to trust God (John 14:1), but we are also to be responsible stewards of God's blessings (Matthew 25:31ff; Romans 2:6; 14:12). Vaccinations are one way we protect our lives.
 - Objection # 2: Immunizations were unethically developed.
 - We live in a sinful world and sin taints everything of this world. We cannot cut ourselves off of everything that may have had a questionable beginning. Instead, we can find a way to make good out of wrongs. By vaccinating, we are not condoning how all vaccines were developed. We can, however, speak out to stop future unethical research.
 - Objection # 3: Immunizations are not safe.
 - Everything has an element of danger, including flying in an airplane, or driving in a car. In an imperfect world there is always the possibility of error. We need to use our good judgement in every situation.

***Please speak with the director if you need an exemption form for any reason.

Snack Policy/Snack Fee

- The children will have a snack time every day. We offer 2 options for all parents.
 1. **Parents supply snacks** for the class. (Half Day: 5 snacks, Full Day: 10 snacks)
 2. Parents can choose to **pay the Snack Fee** rather than provide snacks.
(Half Day: \$30, Full Day: \$60)
- The snacks need to be commercially prepared and in unopened packages. They need to be nutritious and low in sugar. **At no time will home-made treats be given to the children.** You will be allowed to bring special commercially prepared treats on birthdays and “half- birthdays”.
- Your child’s teacher will have more information.
- Messiah’s Children Preschool will be considerate of food allergies in preschoolers. We will work in cooperation with the parents of the preschoolers to the best of our abilities.

Clothing and Backpacks

- Carefully label all clothing (jackets, hats, gloves, sweaters, etc.) and other items sent from home.
- ***Please make sure your child is wearing suitable clothing.*** (Messy crafts, weather, playtime)
- We will play outside, weather permitting. Be sure your child is dressed appropriately for the weather. Shoes must be appropriate for running and jumping. (Please no flip flops)
- ***Backpacks or bags are an important item and are necessary from the first to the last day of school.*** Be certain that your child has a way to carry home those important school projects and information. Please make sure the backpack is large enough to hold an 8 ½ x 11 piece of paper.

Transportation

- The transportation of the child to and from school is the sole responsibility of the parent. Written permission via Wonderschool from the parent is necessary for any other person to pick up the child; this includes carpooling.
- Please notify the teacher of any changes in transportation arrangements. Any change is important and must be noted.

Drop-off and Pick-up

- Drop-off will begin 10 minutes prior to the start of class. We offer two forms of drop-off (pull-up and drop off **or** park and enter.) Each child will have a special code for check in and pick up. Parents can check in their child with this code on an I-Pad. These procedures will be explained in detail at the parent meeting on the 1st day of school. Upon entry, your child will hang up his/her coat and backpack, use the bathroom and then enter the classroom for free-play.
- Pick-up your child promptly at the end of class. At pick-up, check your child out on the I-Pad and check his/her backpack for artwork and important information. Teacher’s aides will load everything from your child’s cubby into his/her backpack. We offer two forms of pick-up (pull-up and we walk your child to you, or park and enter).
- For safety issues, the exterior doors are locked 10 minutes after class. Doors will be unlocked at pick-up time. (This is for the safety of your child.) If there is a need to come to the classroom between these times, please call the preschool at 208-465-4511 and we can open the door or contact us through Wonderschool.

- Your child will be allowed to leave with a parent/guardian or those individuals listed on the Application Form. If an adult arrives to pick up a child, but is not known personally by the teacher, the adult will be asked to provide photo identification—even if the adult is on the authorization list.
- After school care is NOT provided. Parents need to be prompt, as there will be a \$10.00 charge for every 15 minutes a child is left beyond the end of the session. For example, a child left for one hour past the end of class would result in a \$40.00 charge. Any charges imposed under this provision will be payable at the same time or before the next tuition payment, but no later than 30 days after the charges were accrued. Failure to pay fees will be dealt in the same manner described in the “Delinquent Tuition Policy” section.

Discipline Policy

- Discipline is based on an understanding of the child’s needs and stages of development. Discipline and guidance are designed to help the child develop self-control, acceptable behavior, and respect for the rights of others. Discipline is fair, reasonable, consistent, and related to the child’s behavior.
- There will be no corporal punishment. Redirection, speaking with the child, and “time out” periods will be used. You will be notified of any disciplinary problems.
- A child may be asked not to return to the group when one or more of the following conditions are continually observed:
 1. A child’s conduct hurts or endangers another child/children.
 2. There is wanton destruction of property.
 3. A child’s behavior is unruly, disruptive, prevents other children from participating in the class activities, or causes an undesirable atmosphere in the room.
 4. A child requires more of the teacher or teacher’s aide time than our teacher/child ratio allows.

Tuition Payment Policy

- Students enrolled at Messiah’s Children Preschool will be charged a tuition amount established annually by the Preschool. Tuition for the Three- and Four-Year Old program is based on a yearly tuition rate. We offer families the choice of monthly payments or one annual payment.
- For families choosing the annual payment option, we offer a discount of 5% if the payment is received prior to September 1st. A discount is also offered for families enrolling two or more children. The first (eldest) child is charged full tuition and each additional child will receive a 10% discount off the annual/monthly tuition.
- A student shall remain in enrollment with current tuition payments. Tuition for late enrollees will be prorated for the month.
- For families choosing the monthly tuition payment option, payment for **the first and last month’s tuition must be paid on or before September 1st**. Payment for the last month’s tuition will be held as a credit throughout the school year and applied on May 1st. In the event that a parent withdraws a child from school prior to May, the last month’s tuition will be applied to the last month of the child’s attendance. Thirty (30) day written notice is needed to apply the tuition for the last month of enrollment. If thirty (30) day written notice is not given, the tuition cannot be refunded. For students enrolling after September 1st, the last month’s tuition will be due within thirty (30) days of attendance.
- If a child is asked to withdraw from school for behavioral problems, prorated tuition for that month will be refunded. In the event a parent withdraws a child from school, there will not be a tuition refund for that month. If full year’s tuition is paid, a refund will be issued for the following month through May.

- Tuition payment options:
 - Online at messiahnampa.com/preschool
 - Through the Wonderschool app. You will receive an invitation from us once your child is enrolled. You can make a one-time payment, be invoiced monthly or set up recurring payments.
 - Payments made as a check can be placed in the preschool lock box in the front entryway near the office.
 - Payments made with a card via Square in the Preschool office.

CASH PAYMENTS WILL NOT BE ACCEPTED!

Checks or money orders should be made payable to Messiah's Children Preschool. There is a \$20.00 return check fee. We are licensed with the state of Idaho, however, we are NOT certified to accept ICCP payments. In case of extended absences, tuition must be kept current in order to keep the student's name on the roster.

Tuition Delinquency Policy

Messiah's Children Preschool will adhere to the following steps in dealing with delinquent tuition payments:

1. Monthly tuition payment is due on the 1st of each month, if payment is not made by the 10th of the month, a letter will be given reminding the parents the tuition is past due.
2. If after the 15th of the month and no payment is received, the parents will be contacted regarding the late tuition payment and a \$20 late fee will be assessed.
3. If at the end of the month no payment is received, a written letter from the Preschool will be mailed to the parents advising them the tuition is overdue. If the payment is not received within seven (7) days, the Preschool will no longer accept the student, and the last month's tuition will be applied to close the account with a zero balance.

Messiah's Children Preschool does not wish to turn away a student due to tuition issues. Parents can avoid the above steps by making their needs known to the Preschool.
